Sub: "No Objection" for establishment of "Midnapore City College" at Paschim Midnapore as self-financing General Degree College from the academic session 2017-18 under the affiliation of Vidyasagar University.

Whereas, the Moraine Human Resource Development Society, an educational and charitable society registered under the West Bengal Societies Registration Act, 1961, having its registered address at Paschim Midnapore has applied before the State Government for starting a self-financing General Degree College by the name of "Midnapore City College" as per the State Government's Policy framed in this regard along with the required application fees, and

Whereas, in order to examine the feasibility of the proposal of the college, the State Government had constituted a Committee for this purpose and the Committee had visited the proposed site, examined the required infrastructures and other relevant documents and submitted its report, and

Whereas, on examination of the said report it appears that the proposal of the sponsoring society has prima facie satisfied relevant criteria as prescribed under the State Government's Policy and the society is in position to start general degree courses from the academic session 2017-18 with an intake capacity of 1260 students for 12 under-graduate and 8 post-graduate courses under the affiliation of the Vidyasagar University, and accordingly the State Government may now issue a "No objection" certificate in this regard, and

Therefore, considering all this above and also considering the feasibility of the proposal, the Governor is hereby pleased to issue "**no objection**" to the Moraine Human Resource Development Society for starting the proposed self-financing general degree college from the academic session 2017-18 with an intake capacity of 1260 students on the following subjects and under the affiliation of the Vidyasagar University, on the following terms and conditions:-

- (a) The college obtains affiliation from the Vidyasagar University in due course, in B.A (Honourse) and B. Sc (Honourse) in Bengali, English, History, Education, Sanskrit, Mathematics, Chemistry, Botany, Zoology, Physics, Nutrition and Geography and M. A and M. Sc in English, Education Geography, Mathematics, Botany, Zoology, Physics and Nutrition, with 60 (sixty) students in each subject and in M. Sc in Nutrition, with 120 students,

- (b) the college shall have capital fund as per requirement of the affiliating University,
- (c) the space of the college shall provide for academic buildings, library, indoor and outdoor sports facilities for the students,
- (d) fees payable by the students should be in conformity with other self-financed general degree colleges of the State,
- (e) all academic and financial matters of the institution are to be managed and run as per guidelines, orders and/or rules of the State Government/ affiliating University,
- (f) arrangement of Library will be as per norms of affiliating University,
- (g) appointment of teaching and non-teaching staff should be as per rules of the Affiliating University/State Government,
- (h) the college will be outside the purview of West Bengal Colleges (Payment of Salaries) Act, 1978 Act.

Following shall be the terms of conditions of NOC:-

1. The College shall obtain affiliation from the Vidyasagar University in due course.
2. The College shall fulfil all the terms and conditions of affiliation as provided by the affiliating University.
3. The college shall charge course fee similar to that of the other self financing is charging in the same courses.
4. The college shall be out of the purview from the provisions of the West Bengal Colleges (Payment of Salaries) Act, 1978.
