This Memorandum of Understanding (MoU) is made on this 27th day of December, 2024, between Midnapore City College, located at Bhadutala, West Bengal and Jharkhand Rai University, located at Ranchi, Jharkhand. Both institutions are committed to fostering educational excellence and innovation and seek to formalize a partnership that promotes academic collaboration.

1. Purpose

The purpose of this MoU is to establish a collaborative framework for MCC and JRU to:

- 1.1. Enhance educational and research cooperation.
- 1.2. Facilitate students and faculty member's exchanges.
- 1.3. Organize joint academic programs, workshops, and conferences.
- 1.4. Share resources, knowledge, and best practices.
- 1.5. Encourage joint publications and intellectual property initiatives.



1. Scope of Cooperation

The cooperation under this MoU shall encompass the following areas:

1.1. Academic Exchange

- Facilitate the exchange of students and faculty members to promote cultural and academic enrichment.
- Encourage participation in short-term courses, teaching assignments, and other academic activities.

1.2. Research Collaboration

- Engage in collaborative research projects in areas of mutual interest.
- Share resources and expertise to foster innovation and academic growth.

1.3. Conferences and Seminars

- Jointly organize conferences, seminars, and workshops on topics of mutual interest.
- Provide opportunities for students and faculty to present research findings and enhance professional skills.

1.4. Curriculum Development

- Collaborate on the development of new academic programs and courses, particularly in emerging fields.
- Focus on interdisciplinary approaches to curriculum enhancement.

1.5 Skill Development and Training

- Offer joint skill development programs, vocational training, and faculty development initiatives.
- Share best practices in teaching methodologies and pedagogical innovations.

2. Intellectual Property Rights

- Any intellectual property that arises from joint research or academic activities under this MoU shall be mutually agreed upon by both parties. Separate agreements may be executed to address specific intellectual property rights as necessary.

3. Financial Arrangements

- 4.1 Financial arrangements for joint activities under this MoU shall be mutually agreed upon on a case by-case basis.
- 4.2 Expenses incurred from collaborative programs shall be shared according to terms agreed upon by both parties.

4. Duration and Renewal

- 5.1 This MoU shall be effective for a period of 5 years from the date of signing, unless terminated earlier.
- 5.2 Either party may terminate this MoU by providing 90 days written notice to the other party. The MoU may be renewed by mutual agreement of both parties.



5. Amendments

- Any amendments to this MoU shall be made in writing and signed by authorized representatives of both institutions.

6. Dispute Resolution

- Any disputes arising under this MoU shall be resolved amicably through mutual discussions between the parties.


7. Governing Law

- This MoU shall be governed by and construed in accordance with the laws of the Republic of Bharat.


