## MEMORANDUM OF UNDERSTANDING

THIS AGREEMENT, entered into this 9th day of November, 2022, by and between Midnapore City College, West Bengal, India and Department of Food Science and Technology, Jeonbuk National University, Jeonju 54896, Korea.

## WITNESSETH THAT:

WHEREAS, Midnapore City College and Department of Food Science and Technology, Jeonbuk National University desire to promote the enrichment of their research and discovery missions; and

WHEREAS, Midnapore City College and Department of Food Science and Technology, Jeonbuk National University desire to strengthen and expand the mutual contacts between the two institutes; and

## NOW THEREFORE, it is mutually agreed as follows:

- I. Period of Agreement This Agreement shall be effective upon the date of final execution and will remain in force for a period of three years. Either Institute may terminate the agreement by providing notice to the other party in writing.
- II. Funding of Activities There will be no funding or financial benefits from both end.
- III. Nondiscrimination Midnapore City College and Department of Food Science and Technology, Jeonbuk National University agree that no person shall on the grounds of race, religion, color, sex, age, national origin or ancestry, genetic information, marital status, parental status, sexual orientation, gender identity and expression, disability, or status as a veteran be excluded from participation under the terms of this Agreement.
- IV. Use of Name Midnapore City College will not use the name or logo of Jeonbuk National University, nor of any member of Jeonbuk National University's program staff, in any publicity, advertising, or news release without the prior written approval of an authorized representative of Jeonbuk National University. Jeonbuk National University will not use the name or logo of Midnapore City College, or any employee of Midnapore City College, in any publicity, advertising, or news release without the prior written approval of Midnapore City College.
- V. Modification The terms of this Agreement may be changed or modified only by written amendment signed by authorized agents of the parties hereto.
- VI. Prevailing Language Should this document be executed in two languages, the English version of this Memorandum of Understanding represents the understanding of both Parties. Any other version is provided as a translation. In the event of conflict between the two versions, the English version will prevail.
- VII. Non-Binding This Agreement is non-binding and solely for the purpose of establishing a basis upon which Midnapore City College and Department of Food Science and Technology, Jeonbuk National University will continue discussions. Either Midnapore City College and Department of Food Science and Technology, Jeonbuk National University may at its sole discretion terminate discussions for any reason by giving written notice of termination to the other. In the case of a dispute that arises relating to any aspect of cooperation under this Agreement, the parties may attempt to resolve such dispute through





friendly negotiation, or either party may elect to terminate the agreement pursuant to the previous provision. Upon termination, the parties will have no further obligations hereunder.

VIII. Foreign Corrupt Practices Act — Midnapore City College and Department of Food Science and Technology, Jeonbuk National University represent and warrant to each other that they will not, and will not allow their owners, employees, representatives, officers, directors, contractors or other agents to take any action in connection with this Agreement or any separate Activity Agreement to provide, offer or promise to provide, or authorize the provision directly or indirectly of, any money, gift, loan, service or anything of value to (i) any government official (or any agent, employee or family member thereof), (ii) any political party or candidate for political office, or (iii) any person, while knowing that all or a portion of such money or thing of value will be offered, given or promised, directly or indirectly, to any of the foregoing in (i) or (ii), for the purpose of obtaining or retaining business or funding, to direct business or funding to any person or entity, or to secure any other improper advantage.

IN WITNESS WHEREOF, Midnapore City College and Department of Food Science and Technology, Jeonbuk National University have executed this Agreement as of the date first above written.
